
FACT SHEET

TRENCAP L.P. is a limited partnership that owns a significant stake in Noverco. The Caisse acquired the SNC-Lavalin interest in Trencap in November 2010, which led to a 3.7% increase in its indirect Noverco stake.

NOVERCO is an investment company that owns 100% of Gaz Métro Inc. and, as a result, stakes of 71% in Gaz Métro Limited Partnership and 9.1% in Enbridge Inc., a strategic partner of the Caisse for many years.
